Mail a dated copy of your sales receipt including the firearm's serial number, a copy of page 3 of your BATFE Form 4473 (or a signed letter from your dealer, on the dealer's letterhead, stating they refuse to release a copy of the Form 4473) and this promotional form for each eligible FNS™ firearm purchased. Limit one rebate per eligible FNS™ firearm purchase, and one offer per name and address. (The BATFE Form 4473 or Firearms Transaction Record is a U.S. Government document that must be filled out when a person purchases a firearm from a Federal Firearms License holder.)
